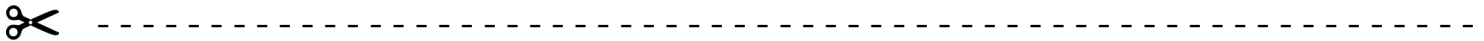

and activities conducted by
Northampton County Conservation District (NCCD)

The workshop will be a combination of classroom instruction and activities, as well as field visits. Participants will construct a rain barrel and take a tour of local conservation Best Management Practices (BMPs) already at work in the county.

Step outside the classroom and see stormwater solutions in action! We'll visit a mix of sites - from large-scale community projects to smaller designs perfect for schoolyards or even your own backyard. Along the way, you'll discover practical, creative ways to manage runoff, protect water quality, and bring more nature into everyday spaces. You'll leave with fresh ideas you can adapt for your students, your school, and your community.

Each educator will be going home with a constructed rain barrel for their school.

The workshop will provide educators with curriculum based material. The content of this workshop meets the Pennsylvania Academic Standards for Science & Technology and Environment & Ecology for grades 4 through 12, including such topics as unified themes, earth sciences, watersheds, environmental health, and humans and the environment.

A Certificate of Completion for six (6) Professional Development Activity Hours will be awarded to Pennsylvania-certified teachers upon completion of the course. Please note, these hours are not Act 48 credit; they are professional development hours that many districts accept toward their own requirements. We encourage you to check with your school district to confirm how these hours can be applied for credit. Homeschool Teachers are welcome
